

**AFFIDAVIT FOR DEFERRED DISPOSITION IN LIBERTY HILL MUNICIPAL COURT**

**SWORN AFFIDAVIT OF ELIGIBILITY FOR DEFERRED DISPOSITION FOR TRAFFIC CITATION WITHOUT REQUIREMENT OF APPEARING IN COURT**

**Eligibility**

A person is eligible to have a traffic violation charge dismissed by completing deferred disposition under Liberty Hill Municipal Court Standing Order Number 8 if:

- (1) the request is made before the date of pre-trial or trial;
- (2) the person holds a valid driver's license from any state or country;
- (3) the person provides evidence of financial responsibility (insurance or bond) as required by Chapter 601, Texas Transportation Code; and
- (4) The Defendant is at least 25 years of age, or is 17-24 years of age and agrees to complete a Driver Safety Course (DSC) approved under Chapter 1001, Texas Education Code.

**Ineligibility**

A person is **NOT** eligible for deferred disposition under this standing order if:

- (1) the person holds a **commercial driver's license (CDL)** or held a CDL at the time of the alleged offense; or
- (2) the violation is alleged to have occurred in a **construction zone with workers present**; or
- (3) the offense charged is **passing a school bus while loading or unloading students**; or
- (4) the offense charged is **passing an emergency vehicle**; or
- (5) the person is charged with **speeding 20 mph or more over the posted speed limit**; or
- (6) the person is charged with **speeding in a school zone**; or
- (7) the defendant has been on deferred disposition in any court within the past 12 months; or
- (8) Defendant has 2 or more convictions for any moving violation in past 3 years; or
- (9) There was a collision arising out of the incident/offense charged in the citation.
